He also worked as a leader in the affordable housing sector where he served as President and CEO of the Metropolitan Boston Housing Partnership and as Director of Asset Management at Lakefront SRO Corporation in Chicago. He studied and has degrees from Manchester Metropolitan University and the London School of Economics in England and has completed the prestigious Advanced Management Program at the Said Business School at Oxford University.

"I am honored and delighted to lead Senior Service America, Inc. at this critically important time in our nation's history," remarks Officer. "Today, more than ever, SSAI's role in providing funding and stewardship support to our national network of local partners is needed. Older American workers are significant contributors to our nation's economy.
